Thank you for wanting to become a part of Richard's Cajun Foods Company social media community. This page has been created for our fans, families, sausage lovers and our associates.

We invite you to share photos, comments, links and videos, as long as you own the rights to the content that you post and share. As a general rule, if you don't own it, don't post it. Any content that you post is and will be considered non-confidential and non-proprietary.

You must be at least 18 years old to participate in and post content to our community.

At Richard's Cajun Foods, we believe doing things right is worth the effort. That is why we continue the time-honored tradition of small-batch, craft sausage making. And while we can't control the messages that our fans and friends post on our feeds, we ask that you follow the rules that you will find below. As a general rule, we do not delete posts from our community. However, we have the sole and absolute discretion to delete any content for any reason. Any violation of the rules could lead to your post being taken down. Please understand that content posted by the public on our social media platforms does not necessarily represent the opinions of Richard's Cajun Foods or our parent company (Tall Tree Foods).

In order to maintain a family-friendly community, we have crafted up a few rules for posts, communications and overall behavior for you to follow.

Rule #1. Safety First: Please do not post personal information like your home address, mobile number or any other sensitive information.

Rule #2: Keep it PG: We want you to share your love of Richard's Cajun Foods with us; we just ask that the content be suitable for this family-friendly page. Please do not post inappropriate content that is libelous, defamatory, harassing, bullying, threatening, abusive or might otherwise be considered offensive. We will fully comply with applicable law, assist law enforcement, and respond to regulatory or other legal inquiries about the identity of anyone posting inappropriate content.

Rule #3: Be Kind: Please use kind words and actions and just you know...be kind to everyone.

It's the right thing to do...and it is the law.

Rule #5: Be Yourself: Do not post any content under a false identity. Any comments from a fake social media profile will be removed at our discretion.
